Pearl Brunning was nominated for Suffolk
Acre's Campbell Cup by members of Eriswell
Parish Council, where she has been councillor
for six years.

The 68 year old did not know she had been put forward for the award, which recognises people who do a lot for the community, until attending Suffolk Acre's annual meeting at the Suffolk Showground, Ipswich.

"I was really shocked to learn I had been nominated," said Mrs Brunning, who lives in Little London.

"I'm quite pleased as I have done a lot in the community over the years, ever since I moved here in 1962."

As well as her work with the parish council, Mrs Brunning actively helps out with St Mary's Church, where she has been treasurer since 1972, and with numerous other groups and activities in the village.

Mrs Brunning was presented with the trophy and a certificate by the Lord Lieutenant of Suffolk, Lord Tollemache, and Suffolk Acre chairman Ian Campbell, who the award is named after.
