In 2007 the Chairman of the Parish Council Mrs. P.Brunning became the first winner of the Campbell Cup awarded to the individual who had made the most outstanding contribution to their community.

PLAYINGFIELD

In May 2009 The Children and Young Peoples Play area was refurbished totally on the young children's former site at a cost of £31,595.00. Grants were received from Forest Heath District Council (£15,099), Suffolk Environmental Trust (£7,900 – upon receipt of £790 from Eriswell Reading Room Committee as a Third Party Contribution), WREN £7898 (upon receipt of £868.78 From County Councillor C. Noble's locality budget); the Parish Council meeting the balance of £698. The new items of equipment from Wicksteed Leisure were Multi-Play Systems– Ice-Storm, and Dragon's Canyon and Swing with 2 flat and 1 cradle swing. Wicksteed Leisure supplied free of charge metal seat, bench, picnic table and litter

The site was fenced with galvanise 1.0 m high bow top fencing and gated at a total cost of £3075.91 with a grant of £2,700 from County Councillor C. Noble's locality budget, £200 from Gerda Securities and £175.91 from Eriswell Recreation Ground and Changing Rooms Management Committee. Installation free of cost from Elveden Farms Ltd.

The Official Opening on 19th September, 2009 to be combined with a mini-fete, grant of £100 received from District Councillor T. Waters.

HIGHWAYS

The strengthening of Weir (Schillings) Bridge completed in 2008 as part of the refurbishment of all the Suffolk bridges over the Cut-off-Channel.

1st June 2008 new Lords Walk gate named the Nathan gate in memory of Senior Airman Jason Nathan killed in Iraq and traffic flow redirected.

B1112/C602 – further safety scheme because continues to be accident black spot. Associated Orders for the A11 Fiveways to Thetford Improvement finally received for comment following being given go-ahead from Department of Transport. The B1112 to pass under the A11 with no direct access to it.

March, 2009 trial initiated designating Wangford Road as a lorry route from the A1065 instead of the B1112. Watch this space!

PUBLIC RIGHTS OF WAY

2009 Confirmation received on route of Public Right of way No. 10 which replaces permanently stopped-up No. 6.

PLANNING

2008 - Approval given to a grain store and drier at Chamberlains Buildings Farm

Noted with pleasure that Elveden Properties Ltd. had lost the Appeal in respect of the development of land south of RAF Lakenheath primarily on the grounds that there was no evidence of an urgent, current need for housing for USAF military personnel families and the fact that the proposal did not accord with national policies regarding the choice of sustainable locations for development and the efficient use of land.

ENVIRONMENTAL

The Spring Clean has become a well-supported annual event. Agreed to apply for adoption of Red Kiosk if B.T. are successful in making it redundant.

HIGHWAYS

March 2011 approval given to the route of the A11 Fiveways to Thetford Improvement – the B1112 will as proposed be an underpass to the dualled A11. Wangford Road not designated as a lorry route.

A Local Safety Scheme for the A1065/B1112 junction was completed in 2010.

ENVIRONMENTAL ISSUES

A 'No fly tipping' sign was erected in Field Lane in 2010.

The Annual Spring Clean goes from strength with more members of the public getting involved.

BT have not been successful in making the Red Kiosk redundant but Elveden Farms Ltd. painted both it and the Letter Box in the former Post Office.

NOTICEBOARD

A new Parish noticeboard for The Square commissioned in 2006 was delivered in September 2011. The board was made by Mr. Robert Webb of Thetford and the Council were very sorry to learn of his accidental death in early November.

Chairman met Matthew Hancock re damage to the church wall but highways could offer no protection from the traffic.

Planning application for 750 homes at Caudle Farm, Lakenheath to which the Council objected due to all the traffic through the village and no road infrastructure proposed.

QUESTIONNAIRE

The recent RoSPA Inspection raised the issue of whether the current swings on the older children's play area needed replacing. The cradle swing and slide have already been removed for health and safety reasons and attention is always drawn to the risk caused by the co-location of the swings to the boundary wall.

The Parish Council currently support the Recreation Ground and Changing Rooms Committee by making a grant to cover the cost of insurance and rent – this currently stands at £400 which equates to approximately £7 per household.

The Council has agreed that it would like to access funding to upgrade the play facilities for both younger and older children and have set aside £500 capital for this purpose in the coming year only. The Committee regularly checks the equipment for safety reasons and maintains the recreation ground free of charge – improved equipment may result in increased insurance costs but it is not expected that this will bring the annual contribution per household to more than £8.

The approved scheme is in the region of £32,000 capital and the Council is currently seeking funding from grant making organisations. Members are, of course, aware that there is a small number of children in the village present but feel that they should take the opportunity currently presented to take advantage of external funding to plan for possible future requirements. The Council will be required to provide evidence that the village supports the improved facilities and to this end members would be very grateful if you would complete and return to Mrs. Pearl Brunning the enclosed questionnaire not later than Tuesday, 25th March, 2008.
