	The clerk has received following verbally from an Eriswell resident: (i) Hedges at Little London and the cottage opposite the old post office need cutting back, they are a hazard. Could the clerk write to Elveden estates. (ii) Shed at Eriswell village is falling down- could the PC take action, please? Clerk to write to occupant. (iii) Email (excerpt) dated 4 th June 2021 from Eriswell village resident: "I have very little faith in the parish council, there appears to be no effort in promoting a neighbourly spirit or active interest in the parish council meetings. I would argue that very little is being done in the village by way of speeding vehicles, poor speed signage, kerb maintenance, footpath clearing. The only interest taken is that of the maintenance of the area surrounding the war memorial or entrance to the houses within that area.	Clerk
	If I were a member of the parish council committee I would take the time to get to know your neighbours in the village and find out what other opinions are in being a part of the village of Eriswell" Councillors felt that the complaints were unjustified. The resident has, in the past, been offered various roles, e.g. strimming, assistance with painting war memorial but he has declined. Clerk to write back with invitation to join the Parish Council so that the resident may take an active role in the community., Some of the complaints e.g. kerb maintenance, are not within the remit of the Parish. 2021/27	UPDATES FROM COUNTY/DISTRICT COUNCILLORS	
a.	 Update from new RAF Lakenheath representative Wg. Cdr. Stu Geary Wg. Cdr. Stu Geary took up his post one week ago. He had been in the RAF for 30 years previously. The Station continues to prepare for the arrival of F-35A aircraft later this year. Councillors explained the primary issues: Parking of deliveries on Earlsfield Road: Wg. Cdr. Stu Geary had discussed this with Jamie, and the agreed solution negotiated by Jamie to use the land across the entrance road. Radcliff Road lighting (9 units were switched off during the transfer of the estate) Wg. Cdr. Stu Geary will look into. 	
b.	Update from C/Cllr Colin Noble: Not present	
C.	Update from West Suffolk D/Cllr S Frost WSDC meets for the first time next week, the only room with enough capacity is at the racecourse. Clearly the pandemic has had a serious effect on the District Council: £1.3 million cost. D/Cllr S Frost has had a Mildenhall hub tour, it looks fantastic. The School at the Hub opened yesterday. Other facilities e.g., Doctor's surgery, etc will open soon He attended a meeting about a similar facility in Bury St Edmunds: once the new hospital comes (end of this decade). The land is at the back of the existing hospital. The current hospital will not be sold for development. Some units are fairly new so will be retained; the rest is falling down. D/Cllr Frost will find out what will happen to the old school. D/Cllr Frost agrees that the grass cutting situation at Earlsfield is a mess. He has confronted the cabinet member responsible and is concentrating on this. The open spaces are privately owned, and the owner does not respond. Clerk to supply email address that she has for Mr Al Qand, the responsible owner. Councillors commented that some of the Earlsfield footpaths are impassable D/Cllr Frost will get clearing these into the WSDC clearance diary. Whilst they were selling the houses, everything looked nice and tidy Property has changed hands many times; now about 6 owners on. The Councillors want to know why West Suffolk Council did nothing about arrangements for the open spaces at the time of handover. The Parish Council would be willing to look at purchasing open space. Councillors suggest that West Suffolk instigate a Compulsory Purchase Order so that there can be some play areas/ proper designated community space. D/Cllr Frost will speak to lan Gillam about this. Appendix A

Reply to resident at item 2021 /26 (iii)

Dear

Your email was read out to the parish councillors at the recent meeting.

The Councillors were sorry to hear that you I have very little faith in the parish council, and that you think there is little effort in some areas. You have raised a number of points which I will deal with in turn:

- 1. <u>promoting a neighbourly spirit</u>. EPC have a website, and a Facebook page. There are five noticeboards in the village, and I put up notices regularly. We have offered voluntary work; I believe strimming and war memorial repairs but unfortunately you emailed to say you were unable to assist at the time.
- 2. <u>active interest in the parish council meetings</u>. Residents are encouraged to attend parish council meetings, the agenda specifically promotes inclusion, and we would very much welcome proactive, positive public participation. We have recently invested in 4 new noticeboards.
- 3. very little is being done in the village by way of speeding vehicles, poor speed signage.

EPC went through the exhaustive process of obtaining site placement for speed posts to support speed indicator devices just prior to the COVID outbreak. The verges belong to Suffolk County Council and only they can give permission to instal the posts. Permission was achieved but the post installation (which has to be done by Suffolk Council) was delayed considerable because of lockdown and staff shortages/ people sick or isolating at SCC. The post have now been installed and the parish councillors will decide at their next meeting which type of speed indicator to purchase. Two parish councillors have volunteered to move the device, set it up and download the recorded information.

Now that the lockdown is eased, training in the use of speed guns can be given by the Police and this project is being taken forward. You may wish to volunteer as a Speedwatch operative, please let me know if this is of interest?

4. <u>kerb maintenance.</u> This is not within the EPC remit. The Highways department at Suffolk Council maintain kerbs. Please see:

5. <u>footpath clearing.</u> This is not within the EPC remit, maintenance of footpaths should be carried out by the landowner or the SCC Public Rights of Way team, see:

EPC do have a very active footpath warden; his reports are in the minutes on the website.
