I write for some advice on the procedure to ask Eriswell Parish Council to adopt the fitting and subsequent maintenance of the Automatic External Defibrillator which was fitted at the shop units near to Lords Walk.

The unit has temporarily been removed and I have been attempting to arrange having it re-installed but meeting dead ends. On messaging with fellow admins on our Facebook page, Libby suggested having it adopted and to contact you.

I am leaving the area in 6 weeks and didn't want to leave this without someone taking ownership, so would be grateful if you could tell me the correct procedure. I can provide more information on it's fitting and upkeep should it be required.

- 5. Who was maintaining the defib?
- 6. How old is it and is it in good working order?
