#### Appendix A

The resident said that that her comments were not a personal attack.

The Resident told the meeting that she has been in her job for some time and that there are certain things (the Resident) is not allowed to do. The Resident gave the following example: If a barrister offered to buy her a drink in a bar, she would have to refuse as she cannot be seen to gain financially.

She told the meeting that she thinks this applies to statutory organisations.

The Resident told the meeting that she is of the opinion that some members of Eriswell Parish Council have misused their position.

The Code of Conduct applies to all forms of Parish Council meetings.

The Resident felt that this was inappropriate behaviour.

The village has always relied on volunteers, each membership has its own rules and responsibilities.

The Resident believes that there was a conflict of interest at the meeting. The Resident commented that, in 1990, Elveden Farms had made workers redundant, and properties were left vacant.

The Resident feels that Elveden Farms do not want to build houses for estate workers. Early in the 2000s Elveden Farms applied for planning permission at Lords Walk: (just under 500 houses). In return there were no shops, no village hall and a relief road was discussed.

The Resident recalled that, at the time, people stood up against this application, at risk of personal cost. 10 years on another planning application was submitted, opposite Lords Walk: Elveden Farms promised a school: however, said it would eat too much into their profit to build a relief road.

The Resident re-iterated that she believes that Parish Councillors were in breach of the Code of Conduct.

She feels that this was an exercise in poor judgement.

In her opinion, Members of committees can attend if they are not public officials

The Recreation Ground Lease should not be contingent on supporting Elveden Farms plans.

The Resident feels that anyone who attended that meeting should recuse planning, Elveden Farms were taking advantage.

Mrs P Brunning, the Eriswell Parish Council Chairman at the time, recalled that several years ago Eriswell Parish Council had an open public meeting and that she went to the meeting with the Queens Counsel.

Cllr A Bibbey commented that there had been some misplaced enthusiasm.

Promises were not made, the attendees from the Recreation Ground Management Committee had the best of intentions.

Mr Tolmie, the Footpath Warden, expressed concern that the agenda covered points he was not happy with. He confirmed that he does not think that any promises were made, Elveden Farms saw an opportunity to talk about their plans.

Cllr Foster told the meeting that If he was going to a meeting the minute he saw Lord Iveagh at the meeting, alarm bells would have started ringing. Cllr Foster told the meeting that he is a civil servant dealing with complaints and therefore he is well versed in complaints. He feels that any meetings should be with appropriate people only and that it is not for the Playing Field Committee to be discussing (any other subjects). If he was looking at this as a complaint, he said that you can draw your own conclusions. Need to be careful going forward.

Cllr Bibbey told the meeting that he felt that the remarks were aimed at him. Because the previous Elveden Farms job holder had retired, he felt that this was an good opportunity to point out empty buildings. He had spoken to Pat Blakey looking at a new lease. Eriswell Recreation Ground have been offered a maximum of 25 years. Potential funders may require a longer term; therefore, the Eriswell Recreation Ground Committee were invited to come and talk about it, hence the meeting, which was also on zoom (limited to 40 minutes).

Cllr Bibbey reported that the attendees were `bushwhacked` by the Elveden Farms agenda, i.e. had no previous knowledge Elveden Farms have offered an in house surveyor to survey what needs doing at the Changing Rooms/ Pavilion (ERG Committee).

Lord Iveagh seems to want to get involved in village affairs much more than previously.

Cllr Foster told the meeting that these are the dangers he talked about.

He said "Let me give you a lesson. Elveden Farms are a multimillion pound business and don't give stuff away. You should take my advice and stop".

Cllr Bibbey felt that the meeting had run on informally after the original meeting had concluded (and the zoom time had run out).

The Resident advised the parish councillors that you really want to move away from it. The only attendees at any further meetings should be not those who attended the first meeting.

Appendix A (2) Statement prepared by the Resident and reproduced here

I have been in my job for 30 years and it is part of our code of conduct I am required to conduct myself in a certain way. There are certain things I'm not allowed to do, for example, if I see one of my barrister colleagues in the pub on a Saturday night and he buys me drink, on Monday morning, I have to report this and include it in a register.

Why? Because I cannot be seen to be accepting any favours from a person who stands to gain financially (i.e. paid work) from their relationship with me.

In the same way that I am governed as an employee by a code of conduct. People in public office are also governed by a set of rules about their behaviour. Those in public office include Parish Councillors because they have been elected to represent the public, by a democratic framework.

Members of a committee, such as the Reading Rooms Committee or the Eriswell Playing Fields Committee, while they serve our community, they do not hold a Public Office.

As Parish Councillors the "Model Councillor Code of Conduct" applies. This is the law (Localism Act 2011) – referred to in the meeting.

It states that all Public Office holders should adhere to certain principles:

Selflessness

Integrity

Objectivity

Accountability

Openness

Honest

Leadership

"The code of Conduct applies to you when you are acting in your capacity as a councillor which may include when:

- You misuse your position as a councillor
- Your actions give the impression to a reasonable member of the public with knowledge of all the facts that you are acting as a councillor" (my emphasis)

The Code applies to all forms of meetings.

For something to fall within the Code, there must be a clear link to a local authority function, or a person's role as a councillor. For example, an argument with a neighbour which does not relate to local authority business would not engage the Code, even if the neighbour happens to know that the person is councillor and therefore complains to the local authority about being treated disrespectfully.

Taxi driver example.

"Attempting to misuse your position as a councillor would include if you threaten to use your position improperly to block someone's planning application. You would be doing something that only a councillor could do even if, as a matter of fact, you do not have the power to do so"

This village relies, and has always relied, on public spirited individuals to get involved on a voluntary basis with the life of the village: the church, the playing fields, the Reading Room, the annual litter pick, the Jubilee Picnic, raising money for the play equipment, the Poor's Estate and the Parish Council.

And because Eriswell is a small village, with a number of unique factors, it often relies on quite a small number of people to fill the roles within the village, these people are the Modern Day "Village Elders".

Consequently, the good people who step forward often wear a number of different "hats"

Parish Councillor / Poor's' Estate Trustee Parish Councillor / Reading Rooms Committee

Equally, to be a member of the Reading Room Committee, there is no requirement to be a Parish Councillor; to be a trustee of the Poor's Estate does not require you to be a Parish Councillor.

But while it may be the same person doing the jobs, it is important to remember that each membership has it's own roles and responsibilities and that conflicts of interest between the roles may arise or might simply be perceived

As has been discussed at the meeting this evening, a meeting was arranged between the Reading Rooms and Playing Fields Committees and Elveden Farms, which owns the RR and PF, and leases them to these committees who maintain these facilities for the use of the village.

This meeting was to discuss new leases being granted to these Committees by Elveden Farms.

From what I have heard discussed this evening, it is clear that a set of very unfortunate coincidences occurred at this meeting:

- Some of those attending the meeting identified themselves as members of the Parish Council
- Elveden Farms were under the impression that they were dealing with the Parish Council (there is even an item on the agenda "Parish Council Hopes for the Future").
- None of those attending the meeting with Elveden Farms appears to have corrected this
  misunderstanding that those in attendance were representatives of the committees.
- Significant Commitments appear to have been extracted from the attendees, in their capacity as Parish Councillors, to support Elveden Farms' housing development plans, in return for the promise of improvements in the village.
- The promised leases have not been signed and now appear to be contingent on the Parish Council supporting planning applications by Elveden Farms.

Here is a history lesson (forgive me Pearl):

In the early 1990s, Elveden Farms made the bulk of their workers redundant. People who had dedicated their entire lives to working on the Estate.

The number of people who work on the Estate is now very small.

The Estate has lots of properties in Eriswell, Elveden and Icklingham that remain empty – some have been empty for nearly 30 years. These could be bought back into use for Estate employees (which would improve the environment in those villages).

Elveden do not want to build a few houses for locals and Estate workers – the fact that they talked about a relief road should have been a clue to the size of their proposed development.

In the early 2000's Elveden applied for planning permission for houses on the area to the side of the Lords Walk Housing, right across to the 1065 / B1112 junction. Although the application was for just short of 500 houses, Forest Heath planning officials noted that the net effect of agreeing to this application would be to give the green light to 2000 houses, that Eriswell would be swallowed up by a massive housing estate. The type of housing proposed would not be bought or allocated to local people, or estate workers, it was high value executive housing. This development included a "relief road", going up the side of the Lords Walk housing between the A1065 and the B1112, but NO OTHER community facilities.

On that occasion, the residents of Eriswell, many of whom depended on Elveden Estates for their HOMES, stood up to Lord Ivagh and Michael Douglas and opposed this development and it never went ahead. Many of the people who had the courage to oppose this had a lot at risk personally, nevertheless they recognised that while Elveden Farms would be going "kerching!" it would be a disaster for people already living in this area and a disaster for the environment.

Approx. 10 years later, Elveden applied for planning permission for land on the opposite side of the B1112, opposite the Lords Walk, again executive houses, but on this occasion, they offered a school, but said that they would not create a new road as this would cost millions of pounds and would dent their profits. Again, residents from the village, along with new residents from the Lords Walk housing, who realised that this development would have a negative impact on the enjoyment of their homes as well as on the old village, took a stand against this application.

Returning to the Code, in the same way that the councillor who threatened the taxi driver's licence because he was a councillor (whether he had the power to do so or not) was in breach of his obligations, making promises as a Parish Councillor to support a large developer's plans, has the potential, I believe, to be a breach of the Code.

At the risk of labouring the point, all this has the appearance of undue influence (and I emphasise this word "appearance" because I am not suggesting that there has been any bad faith on the part of those involved, only misplaced enthusiasm).


#### **Proposed Permissive Path**

There exists a need to connect the villages of Lords Walk (aka Earlsfield) to the facilities situated in the village of Eriswell (pub, church, Reading Room and recreation/play grounds). As there is also no safe walking access to natural green spaces, with Lords Walk being fenced in on all four sides, this proposal also satisfies this important community need. The shortest and safest route is documented in this proposal.


The proposal extends two existing cement footpaths in Lords Walk through the farm fence line and into Holleys Belt and thus formalises the path already used by the residents.

The path then proceeds West for a short distance (185m) in Holleys Belt, then South alongside an existing tree line (name unknown) for 390m so as to meet up with Bridleway 4 and safely onwards to the Village of Eriswell.

Hi Nicola,

Sorry to trouble you, but I / we need to contact Suffolk Highways as a matter or urgency.

You may recall that we spoke about the drain at Sparkes Farm Corner.

Well last night the noise and vibration from speeding lorries going over this became very worrying - every time one passed there was a loud bang and my whole house shook.

I decided to go over this morning and put a traffic cone on the area, in the hope that drivers would see this and avoid the area (the speeding is getting much worse, as virtually no-one is adhering to the 30mph limit any more at this point because there aren't any signs and drivers are picking up speed as they exit the village), and the drain now looks to be on the verge of collapse. There is another drain on the same side a short distance away which is also in poor condition.

If this drain collapses (highly likely given the speed and the size of the vehicles), there is likely to be a serious accident.

I'm happy to contact Highways myself if a specific contact can be identified, but don't feel that leavening a message with a general call taker would be enough in these circumstances.

On 14 January 2022 at 15:25 the SID was installed on the B1112 on the pole adjacent to Sandra's house. The SID was positioned to monitor North bound traffic (Eriswell to Lakenheath). Traffic speed was measured up until the morning of 07 February 2022 (battery died, measurement stopped).


There are between 3000 and 3300 vehicles per weekday passing this point heading towards the base.

There are between 1900 and 2600 vehicles per day over the weekend heading towards the base.

The 85th Percentile Speed (most people) travel at 32.0 MPH past his point.

Using the data gathered from the Volvo Dealership (January - South bound measurements), there are up to 6400 vehicles per day travelling on this section of B1112.
