

Appendix A

Council Update January 2023: In addition to the routine training sorties conducted throughout January 2023, the 48th Fighter Wing had aircraft deployed to Poland for deterrence operations on NATO's Eastern Flank and they hosted Norwegian and Netherlands F35 aircraft for Exercise Point Blank during the period 17-20 January. 48th Fighter Wing has been shortlisted for the Commander in Chief Installation Excellence Award for 2021/22. Consequently, the Station hosted a visit by the Commander in Chief Installation Excellence Award Review Team on 9 and 10 Jan 23. During their visit, the Review Team engaged with UK Military personnel, Honorary Commanders and members of the local community about 48th Fighter Wing's collaboration and engagement with, and their contribution to, the Host Nation. I will let you know the outcome of the competition in due course. The MOD Surgeon General (UK 2*) visited the 48th Medical Group Hospital on 12 Jan 23, and RAF Lakenheath hosted a VIP visit by the US Ambassador to the Court of St James on 27 January. I delivered a presentation on the USVF and my role as the RAF Commander at the Norfolk RBL Annual Conference on 4 Feb 23. The agreement for 48th Fighter Wing to use a small parcel of land outside of Gate 2 (Lords Walk) for parcel/shopping goods deliveries and collections has been signed, sealed, and delivered by the Defence Infrastructure Organisation and Elveden Estates. It is hoped that the land will be formally handed over to 48th Fighter Wing later this month. Finally, please note that 48th Fighter Wing lost a lot of training sorties throughout November and December 2022 due to poor weather in the early mornings. Consequently, to try and avoid the bad weather, they are trialling starting their flying programme later in the day and flying later into the evening throughout January 2023



13/01/2023 to 28/01/2023 into Eriswell village - Traffic from direction Lakenheath

On 13 January 2023 at 15:00 the SID was installed on the B1112 on the pole positioned opposite the Volvo dealership, The Street, in the village of Eriswell. The SID was positioned monitor traffic coming from the direction Lakenheath heading South towards Eriswell Village Traffic speed and volumes were measured up until 14:55PM on 28th January 2023 (14.5 day)

There are between 2600 and 3200 weekdays passing this point.

There are between 1700 and 2500 vehicles per day over the weekend heading towards the village.

The busiest times during the week are 07:30-08:30 (Avg. 250 cars p/h) and 16:00-17:00 (Avg. 250 cars p/h).


The 85th Percentile Speed (most people) travel at or below **34.8 MPH** past his point.

The 50th Percentile Speed (half the traffic) travel at or below **28.9 MPH** past his point.


The fastest speed recorded during this 2 week period was **65MPH (x1) and 60MPH (x5)**. The is positioned 670m past where the 30MPH zone starts (460m past the T-junction).

- Must complete a NEW register of interests within 28 calendar days of the election
- The register of interests will be submitted to the Democratic Services Team at West Suffolk Council

- In general, do not issue any publicity which might be seen as intended to influence voters.
- Local authorities should not publish any publicity on controversial issues or report views in such a way that identifies them with any individual members, or groups of members.
- Publicity relating to individuals involved directly in the election should not be published.
