Further to the guidance in the October 2022 NALC legal bulletin, NALC now knows that Monday 8 May will be an additional bank holiday to mark the coronation of HM King Charles III. The 2023 local **election date is Thursday 4 May** and councillors would ordinarily take office on Monday 8 May. The view is that **councillors will now take office on Tuesday 9 May** making the relevant 14-day meeting period for the purposes of paragraph 7 (2) of Schedule 12 to the Local Government Act 1972 Wednesday 10 – Thursday 25 May inclusive.

This is an area where we are aware there have been different interpretations of the computation of days and we have not counted Sundays in our 14 day calculation.

Councils may have questions about pre-election publicity because of any Coronation related events pre-election. Our advice is essentially limited to councils ensuring that publicity is in the name of the council rather than any individuals. I am emailing for further clarity on a Tree preservation order (TPO 031), I am deeply saddened and frustrated with the process and decision on a tree on my property which is causing damage. I went through the correct procedures to have the tree taken down due to 4 main factors affecting my current property. These being;

- Roots growing under my property and affecting my structure/footings which in time will cause the house to subside.
- Roots growing under the path and causing damage to the path.
- Roots growing and causing damage/ potentially life critical damage to an underground gas tank I
 have in the front garden.
- Dead or damaged high branches.

All of this process was going ahead while I was deployed in Iraq and I won't lie it put a huge amount of stress on me balancing a highly demanding job in addition to having to work through the night contacting the right people to, document the tree, complete a survey, submit relevant forms and get arboriculturist reports. The first attempted process I had was when submitting through the portal that I needed a report within 24 hours, although this was unrealistic as I think I speak for everyone that a survey and report takes a lot of time to document and report. Once a report was done by both a local arboriculturist with supporting images I was then told I needed a full tree survey done, which I managed to contact home again (with little to no communications) and get my father (Kev Gattlin) to organise on my behalf.

I then when was informed that an officer went out to my property and couldn't note any damage, which I have sent clear images myself of and had documents produced my arboriculturist and tree surveyors. I find this incredibly disheartening as the main reason for wanting the tree taken down is due to my personal safety within my house (and the worry of damage to the gas tank which frightens me) and civilians using the path. I clearly stated when applying to take it down I would be more than happy to plant multiple other trees in my front garden as I love trees and greenery.

So far I have spent over £1300.00 on tree surveyors, arboriculturist and council fees and feel I have been overlooked.

Finally to add to my frustration I was reading the planning applications page on the West Suffolk councils website this morning and noted that a resident with the exact tree as mine living on Lords walk had cut theirs's down. Firstly without the correct permission from my understanding, and without any survey/ arboriculturist reports produced. They're where no impact to their property or path and was in the far end of their garden. This property was 4 Dogwood walk, RAF Lakenheath, IP27 9QP.

I have attached an annex to one of the tree surveys taken this year which provides physical evidence that the aggressive root is growing under my house and has the potential to cause significant damage. (Annex A).

I please request formerly that you will reconsider my application and the tree taken down by a qualified tree surgeon.

On 12 November 2022 at 15:55 the SID was installed on the B1112 on the pole positioned adjacent to No 36 The Street, in the village of Eriswell. The SID was positioned to monitor traffic coming from the A1065 on the B1112 heading North towards Sparkes Farm. Traffic speed and volumes were measured up until 13:10PM on 31 December 2022.

There are between 2700 and 3400 weekdays passing this point.

There are between 1700 and 2600 vehicles per day over the weekend heading towards Sparkes

The busiest times during the week are 07:00-09:00 (Avg. 405 cars p/h) and 16:30-18:30 (Avg. 290 cars p/h).


The 85th Percentile Speed (most people) travel at or below 31.8 MPH past his point.

The 50th Percentile Speed (half the traffic) travel at or below 27.4 MPH past his point.


The fastest speed recorded during this period was 60MPH (x5). The SID is positioned 680m past where the 30MPH zone starts.

Appendix H B1112 Road Stud condition Report October 2022

With the B1112 road closed from the Lords Walk roundabout to Eriswell Road (T-junction to Mildenhall) it was an ideal time to closely examine the condition of the road studs (aka catseyes).



What follows is the summary of observations and findings.

This section of road carries in excess of 9000 vehicles daily during the week.

The road is a main single-carriage way and for the most part has a speed limit of 60MPH.

There have been 2 road deaths and numerous unreported incidents in the last 6 years. If there are no injuries or deaths, a road traffic incident does not occur in any official database.

Although this section of the B1112 is just over 1 Km in length it has 5 bends in it, 1 very tight and narrow.

Being unlit, the driver relies heavily on good road markings and road studs.

It could be argued that although this road is legally categorized as a B-Road, it carries the volumes and vehicle type mix typical of an A-Road.

There are 116 road studs on this section of road. All 116 were examined and NONE were fit for purpose. Each road stud was individually photographed in high definition (https://photos.app.goo.gl/JBTPXoDvpYPeD1Mo7) and individually analysed with examples as an annex to this report. To be fit for purpose a road stud contains 4 cats eyes (2 facing in each direction) and is visible and illuminated by an oncoming vehicles headlights.

However, we will continue to monitor the location as part of our routine inspections, and if the matter worsens significantly, we will take action.

Employers are encouraged to implement this pay award as swiftly as possible.

Backpay for employees who have left employment since 1 April 2022

If requested by an ex-employee to do so, we recommend that employers should pay any monies due to that employee from 1 April 2022 to the employee's last day of employment.

When salary arrears are paid to ex-employees who were in the Local Government Pension Scheme (LGPS), the employer must inform its local LGPS fund. Employers will need to amend the CARE and final pay figures (if the ex-employee has pre-April 2014 LGPS membership) accordingly. Further detail is provided in section 15 of the HR guide which is available on the employer resources section of www.lgpsregs.org"

The attached Annex lists the new pay scales for clerks and other employees employed under the terms of the model contract including SCPs 50 and above. These calculations are based on the changes agreed by the NJC. These should be retrospectively applied from 1 April 2022.
